### **Old Business**

Some of those books will be scanned for thrift. People want to know when the library can take donations again. Proposal, they can donate books now, if they are willing to work the Booksale.

**Holiday event:** The Rotary decided to do the Drive through instead of tree lighting and Santa at the library. The rotary will probably not sponsor the Santa event again. Donna has gotten the OK the use the churches tree if we do need it. If we decide to do the Santa event, Tim will ask the fire

department. If we can get things today for the event, we are going to do it on December 6 at 6:00pm. Melia Gordon knows Santa and will find out if he can be at the library on that date.

**Construction**: Local history room is almost done. They should be completely done with history room within 2 weeks. Electrician is working on things. Construction should be done by November first ish.

**BHBL Dinner** – March 15. There is still a lot of work involved. It should be easier this time. We will pick the menu in collaboration with Nikki. Melia sent Sue an email asking if that date was still available.

In person/Hybrid meetings: We would like to keep zoom meetings available. We would like a nice Hybrid option. SALS recommends the OWL. It is a 180 camera and Microphone setup. It can show the zoom people on a Screen at the front of the room. If we have the OWL by the next meeting, Donna can do a Hybrid meeting in November, but she would need someone to be there to help her set it up. OWL is approximately \$1000.
